
RESTRICTIONS ON GATHERINGS IN PROVINCES AND TERRITORIES: COVID-19

All provinces and territories across Canada have declared Public Health Emergencies as a result of COVID–19. To limit the spread of COVID-19, they have all placed restrictions on gatherings – both indoor and outdoor. These vary from region to region and include a number of exceptions, which can be viewed on their respective government websites. Any gathering, whether it be for essential or non-essential reasons, continues to require strict adherence to physical distancing guidelines of 2 metres or 6 feet between individuals. The following information sheet provides details on the date that public health emergencies were declared in each province and territory, their respective restrictions for gatherings, along with a government source for more information.

Alberta – 15
British Columbia – 50
Manitoba – 10
New Brunswick – 10
Newfoundland and Labrador – 5
Northwest Territories – 10 (outdoors only)
Nova Scotia – 5
Nunavut - Ban of all gatherings
Ontario – 5
Prince Edward Island – 5
Quebec – Ban of all gatherings
Saskatchewan - 10
Yukon – 10

Quebec

Public Health Emergency: March 13, 2020 Prohibits all indoor and out gatherings

Prince Edward Island

Public Health Emergency: March 16, 2020

Gatherings of more than 5 people are prohibited.

Alberta

Public Health Emergency: March 17, 2020

No gathering of more than 15 people is allowed in one indoor or outdoor location.

Ontario

Public Health Emergency: March 17, 2020

Prohibits gathering of more than 5 people (or 10 people from single household for funeral service)

Saskatchewan

Public Health Emergency: March 18, 2020

Limiting the size of public and private gatherings to a maximum of 10 people

Public Health Emergency: March 18, 2020

All in-person gatherings of any size are strongly discouraged with a limit of 50 people at all public

gatherings.
